# PRESIDENTIAL UNIT CITATION (PUC)

In my recent letter I explained how we were ignored, leaving action to the Air Force with not intervention on the part of the President or his staff. Bob Shuler, his lead man during the race indicated that VP Chaney would be interested in pursuing such an effort. We will see. Some of you expressed a sincere displeasure to having the former President signing the document, so I guess those have lucked out

#### **CONVENTION 2001**

It seems that we will have 50 plus attending the trip to England. For those of you going, we are planning to pay in one lump sum, the cost of lunch and dinner. For that I need you to send me \$41.00 to cover the cost of the two meals. The treasury fund will cover several English friends to the Group Day dinner at the Green Man. We plan to go on Tuesday, as a separate trip, to Barsham to visit with the locals and view the memorial they erected to the Reid crew. Thus I need to know if you plan to attend this trip. The decision is whether to hire a small bus or to go over in a few cars. Please respond to both by at least the first of August to facilitate planning.

## **CONVENTION 2002**

The convention will be held from 3 thru 7 October. As in 1996, the Octoberfest will be going on in Savannah. We will have shuttles to the Museum on Friday and Shuttles to both the Museum and Savannah on Saturday. There will be outside trips and a tour group will be in the Hospitality Room to allow your selection. I should have a selection of sorts by next newsletter. This way the outside trips does not run the cost up for everybody, only those who want to go. Also, the tour groups provide the necessary transportation. The room rate to \$60.50 per night, single or double and with a small addition fee covers. I will be going to Savannah in May and hope to get most of the arrangements set up for 2002.

# **NEW COMMUNICATION**

However, we are in advance planning to obtain funding to cover the cost of compiling and verifying the group records and biographical data of the 14 Bomb Groups and Headquarters. Following Excom review in April, we will solicit sponsors. The 44th and 467<sup>th</sup> BGs have invested their own funds and their databases are approximately 95% and 25% complete, respectively: and (3) We will continue to support the 2ADA memorial Trust and the Mighty Eighth Air Force Heritage Museum. The 2ADA, thru direct donations and thru individual groups, have invested over \$500,000 in the Heritage Museum.

Just as we won the battles for freedom in the skies over Europe, we can press on to complete our legacy and record of all who served, with the knowledge that we gave our best to honor those that gave their all.

## FROM A LOVING GRANDSON

Joe R. Ramirez past away 3 1/2 hours ago at 9:30 p.m. PST on 01/29/01. He was 85. He had high blood pressure Monday morning and the paramedics rushed him to intensive care at the Whittier Hospital where he remained conscious and semi-alert. It was later learned that he had suffered yet another mild stroke and had a kidney infection that was adding to his ailments. I came to visit him at 3 p.m. in the afternoon. We spoke briefly about the Superbowl and I thanked him for everything he had done for me, I also told him he was like a father to me. Before I left him I said to him "Don't go anywhere, all right?" he responded, "Oh no, I'm not going anywhere!" My grandma and mother came to visit him a couple of hours late and left around 8 p.m.

I returned to see him at 9:25 p.m. There was a nurse drawing some blood and when I walked in my grandpa was happy that I returned. I asked him if he wanted another blanket, he declined and said, "I'm O.K." Within a matter of minutes, he was having a little trouble breathing, we were holding hands at the time, I called for a nurse, she came in and tried to help him breathe, she hit the "Code Blue" button and called for support staff, and in an instant, he had slipped away. Doctors and nurses tried vigorously for 20 minutes to revive him. His heart had stopped. It was surreal. I think he waited for me to return to say good-bye. I am so glad he wasn't alone when he left.

My grandpa Joe was the strongest man I ever knew. For the last decade he has struggled to stay alive. He was an honest man. A straight shooter. A just man. A fair man. He would always help someone in need. He was a God fearing man and he loved his wife and his family. He will be sorely missed. We rejoice in his 85 years of life on this planet, we look with fond memory of all his successes, his accomplishments and his friends. Thank you Fred and all of you who knew him, for being

## Air Force Museum Receives Donation-Cille Day

State representative Billy Montgomery and area businesses gave the 8th Air Force Museum Association at Barksdale Air Force Base a \$15,000 donation Wednesday. The donation came during a ceremony at the museum to support the restoration effort of the museum's rare B-24 "Liberator." The B-24 was the most produced American aircraft of World War II. Nearly 18,000 B-24s were built, but only 12 exist today. The contribution will pay for the last major exterior component—the engine cowling, which helps protect and streamline the airplane's engine.

Others who contributed to the donation were the area's five casinos, the Shreveport-Bossier Convention and Tourist Bureau, BellSouth, AEP Southwestern Electric Power Company, and the Shreveport Chamber of Commerce. The Liberator will be restored this year and unveiled during ceremonies in October for the 44th Bomb Group Association reunion.

#### **PLEDGE LETTER**

An open letter to all who have served in the 2nd Air Division during World War II

I'm writing to you concerning the 2nd Air Division Memorial Library in Norwich England. It is directed to you whether or not you have participated in the 2nd Air Division Association. The Memorial belongs to all of us. the War's end many of you were asked to donate money to provide for a Memorial to honor ALL those 6700+ men of the 2nd Air Division who did not return. At that time, you probably thought you were donating to a USUAL Memorial, constructed of brick, marble or stone as was the normal approach. In fact, you may not even remember that you contributed at all. Nevertheless, in time, the decision was made to construct an entirely new type of Memorial---a LIVING tribute in the form of a Library. This Living Memorial has become, to our knowledge, the only one of its kind in the world! If we take care of our Memorial Library, it will shine like a beacon down through the years - a fitting tribute, indeed, to those men who gave their lives.

Although the money to construct the Library was left in Trust, the money required to OPERATE the Library

was not provided. Our English friends appealed to the 2nd Air Division Association for help, and help it did! The 2nd ADA has provided almost all of the operating funds for over 30 years! The Capital Fund of the Memorial Trust is presently over 700,000 pounds. To be sure, this is a great deal of money, but we operate the Library on the INTEREST & DIVIDENDS accruing to the Capital Fund. The result is that about 5% of this 700,000 pounds provides for the day-to-day expenses, including salaries. If we are to provide for the Memorial Library in PERPETUITY, we must now provide the necessary funding! Virtually every day you are asked to reach in your pocket for a contribution to a myriad of monuments, markers, plaques, busts, B-24 models, et al. We acknowledge that all are indeed worth your attention. We are also asking for your financial help. BUT OUR APPROACH IS DIFFERENT!

A beautiful new Memorial Library is presently rising out of the ashes of the old one. If YOU GIVE, it will remain beautiful for the next 50/100 years or more.



#### TAPS

We have all heard the haunting song, "TAPS." It's the song that gives us that lump in our throats and usually creates tears in our eyes. But, do you know the story behind the song? If not, I think you will be pleased to find out about its humble beginnings:

Reportedly, it all began in 1862 during the Civil War, when Union Army Captain Robert Ellicombe was with his men near Harrison's Landing in Virginia. The Confederate Army was on the other side of the narrow strip of land. During the night, Captain Ellicombe heard the moans of a soldier who lay severely wounded on the field. Not knowing if it was a Union or Confederate soldier, the Captain decided to risk his life and bring the stricken man back for medical attention.

Crawling on his stomach through the gunfire, the Captain reached the stricken soldier and began pulling him toward his encampment. When the Captain finally reached his own lines, he discovered it was actually a Confederate soldier, but the soldier was dead. The Captain lit a lantern and suddenly caught his breath and went numb with shock. In the dim light, he saw the face of the soldier. It was his own son. The boy had been studying music in the South when the war broke out. Without telling his father, the boy enlisted in the Confederate Army.

The following morning, heartbroken, the father asked permission of his superiors to give his son a full military burial despite his enemy status. His request was only

partially granted. The Captain had asked if he could have a group of Army band members play a funeral dirge for his son at the funeral. The request was turned down since the soldier was a Confederate. But, out of respect for the father, they did say they could give him only one musician.

The Captain chose a bugler. He asked the bugler to play a series of musical notes he had found on a piece of paper in the pocket of the dead youth's uniform. This wish was granted. The haunting melody, we now know as "Taps" used at military funerals, was born.
