The new Board of Directors voted to amend the By-Laws to add two additional Directors and to allow no more than 2 Associate Members to be Directors and no more than 2 Associate Members to be Officers. The effort was to get Associate members into the governing of the Association. Andy Wilkinson and Brian Mahoney were asked and accepted the positions. Tony Bell requested to be relieved of his VP status and Bob Davis was asked and accepted the position. The action was covered at the banquet and action was approved by the membership. It's November 2004 -Veterans Day is here and we're looking forward to a Happy Thanksgiving, Happy Hanukah, Merry Christmas, and a Happy New Year in 2005. (Back in 1942 - 1945, how many of us expected to be around for the new century, much less 2005?)

Looking back, 2004 has been another good year for the 467th BG with continued positive operations, including another successful reunion - this time in Covington, KY. Alter the sudden death of Director "Bodie" Malone, Paul Hatten has agreed to rejoin the Board of Directors and serve for the remainder of "Bodie's" term of office. And, following Tony Bell's request to resign as Vice President for personal reasons, Robert Davis was selected by the New Board to fill in for Vince Re agreed and was elected to serve another 5 years as Director. The Board of Directors has been increased from six to eight members and Andrew Wilkinson end Brian Mahoney have been named to the Board.

The 2nd ADA also had a very good year. The 57th Annual Convention, held in Philadelphia, May, 27 - 30, 2004, was my first convention as your representative. The Executive Committee meetings were all-business pros and cons of the agenda items were submitted to the members before the meetings; discussed; and then voted on. Five of the fifteen Memorial Trust Board of Governors were in attendance, including Chairman Mathew Martin, Immediate Past Chairman (and long time friend of 467th) David Hastings, and (friend of the Stevens family since our visit to Norwich in 2001) Andrew Hawker, all of Norwich, and, from the US, Charles Walker (445th BG), and Joseph Dzenowagis, Jr. (son of Joseph Dzenowagis (467th BG). A donation of \$100, 000 was made to the Memorial Trust's Capital Fund (for the Memorial's continuance). And a donation of \$25,000 was made to the 2ADA/Fulbright Fund (for continuance of an American Librarian). A donation of \$180,000 was received from our British friend, Bernard Matthews (whose company is the world's largest turkey farmer) and a donation of S400.000 was received from the estate of Theodore "Ted" Kaye (445th BG). (Both amounts are approximate.)

NEWS FROM STATION 145

THE LEGACY OF THE 2nd AIR DIVISION USAAF and the ASSOCIATION.

As the generation of Norfolk people who knew the 2nd Air Division USMF during the war are now well past their "Three score years and ten" it is an opportune time to look back and give thanks for the great legacy that the 2nd Air Division USAAF and their Association have left to all of us on both sides of the Atlantic. Here are just sixteen items that we should be thankful for but I am sure there are many more.

- 1. Without the arrival of the 8th Air Force and the 2nd Air Division USMF in 1943 to join us in the fight for freedom I doubt if we or our families would be here today and living in freedom. Your bravery, sacrifice and friendship are a vital part of our history
- 2. Without the 2nd Air Division USMF being with us in those dark days from 1943 to 1945 we would never have made the wonderful friendships that we enjoy today and which are now being passed on to the next generation. Your arrival was like a bright light at the end of a dark tunnel after we had endured three years of war, from the Fall of France, Dunkirk and the threat of invasion, the Battle of Britain and then the Blitz.
- 3. Without the vision of the 2nd Air Division USMF in 1945 to leave a "Living Memorial" we would not have the outstanding 2nd Air Division Memorial Library that we enjoy today the only one of it's kind and loved and appreciated by people from all parts of the world.
- 4. Without your Memorial Library I doubt if the 2nd Air Division Association would be as strong as it is today and many of the friendships made during the war would have faded away. Over the years several 2nd ADA members have said that your Memorial was the glue that kept your Association together. Your Library has over the years strengthened the friendships and the links between the United Kingdom and the United States.
- 5. Without the massive financial support and encouragement from the 2nd Air Division Association over many years, the 2nd Air Division Memorial Library would not be in the very successful and much admired position that it holds today.
- 6. Without the 2nd Air Division Association there would be no Heritage League as it was the 2nd ADA Executive who backed the suggestion from the Memorial Trust to involve the next generation.
- 7. Without the 2nd Air Division Association there would not have been all those wonderful Annual Conventions in the USA you are a truly great family.
- 8. Without the 2nd Air Division Association there would not have been the Norwich Conventions which have done so much to strengthen the unique ties of friendship made in the war years. Memories that will last forever and thankfully captured on film by the Dzenowagis family for present and future generations to enjoy and relive those amazing and memorable occasions.
- 9. Without the support of the 2nd Air Division Association there would not have been the return to Gt. Britain in 1992 of a B.24 Liberator. A visit which achieved so much for the 2nd Air Division USAAF, the Association and your Memorial Library.
- 10. Without the 2nd Air Division Association in 1995, Norwich would not have had the finest 50th Anniversary VE Day Parade outside London. We were the only City in the United Kingdom to recreate the original 1945 Parade thanks to all your support and hard work by your Executive. Norwich and Norfolk will never forget the Parade, the Cathedral Service, your Fanfare and the Theatre Royal show in the evening.
- 11. Without the 2nd Air Division Association your Memorial Library would not be the only one in Europe that enjoys a full time Fulbright Scholar Librarian each year in perpetuity. A gift of untold value.
- 12. Without the 2nd Air Division Association there would not be the B.24 Liberator paintings hanging in so many places, on the RAF and USAF bases, the City Hall, the County Hall, the Forum, Norwich Airport, Wymondham College and the Village Halls. Al1 serving as a constant reminder of what you did and what you have achieved.
- 13. The 2nd Air Division Association has also supported many other causes, the bronze B.24 at your Air Force Academy, the Mighty Eighth Heritage Museum at Savannah and the Mural in the wartime chapel at Wymondham College to name but a few.
- 14. Without the 2nd Air Division Memorial in Norwich there would not be the close links that the airmen and airwomen of today enjoy both with you the Association and the Norfolk community. As we have seen at USAF Mildenhall your armed forces of today now understand why there is such a special of friendship in East Anglia and that is thanks to you The 2nd ADA.
- 15. Without the 2nd Air Division Association and that wonderful Dzenowagis family we and future generations would not have that amazing and historic video collection, telling of your exploits, bravery, sacrifice, memories and conventions both in the USA and here in the United Kingdom. This collection will continue to enlighten people down the ages.
- 16. Without the 2nd Air Division Association we would never have had that truly memorable occasion in 2001 when the new 2nd Air Division USMF Memorial Library was opened. Despite the terrible events of 9/11 that year, you still came over undeterred to see your "Roll of Honor" return home.

Finally, the outstanding vision, generosity and hard work of the 2nd Air Division Association membership were recognized in 2001 with the award to the Association of the Freedom of the City of Norwich. The only non-British organization to receive our highest honour.

Now in 2004, as we sit in your beautiful library or stand on the runways of your old bases we realize even more that we can never thank the 2nd Air Division USMF enough for joining us in 1943 and for your vision in 1945 to leave a "living memorial" to your friends who died and those who survived during that heroic fight for world freedom. In the years of

peace we must also thank the 2nd Air Division Association members and their Executive for carrying on the support for the Memorial and strengthening still further those unique ties of friendship between our two Countries.

Look back on what you have achieved and be proud...... you deserve to be as not many other organizations have this outstanding record.

BOARD ACTIONS SINCE OCTOBER, 2003

- Board members approved the donation of \$1,000 each to the B-24 Bronze Model for the San Diego memorial Park. The model should be in place by November 2005. Thus our consideration for San Diego has been moved to 2006. The Board also approved amendments to our By-Laws that allow Board Meetings to be conducted by e-mail, changed the terms of Directors, included Associate Members to be Officers and established that all Officers Terms are for 3 years. The matter for Convention 2005 will be discussed in the Business meeting.
- 2. For the open 3-year Director's Term of Bodie Malone, Paul Hatten has volunteered to serve the remaining term. For the ending terms of John (3-year term) and Vincent Re (5 year term) each has been asked to volunteer for an additional term. Others will be asked from the floor at the Business Meeting. The vote will be held at the business meeting.
- 3. The Mighty Eighth AF Heritage Museum is having a fund drive and the Board authorized the sum of \$1,000.00 for the installation and up-dating of the 2ADA display area which will include the B-24 fuselage that was shipped over from England. Previously we donated \$2,300.00 in the name of Col. Shower for the nose up-date.

TREASURY REPORT

The Operation Fund Balance of the Association, as of October 1, 2004 is \$14,977.53. Compared to the September 21, 2002 Operating Fund Balance of \$15,922.42.

OLD BUSINESS

A discussion covered getting younger people into the active role of the organization and led to Officers and Directors. Tony Bell expressed the concern of his family regarding his health to cover the functions of VP should Ralph not be able to continue. Walt Mundy said the 2ADA did not seemed interested in getting younger people into their role. It was discussed that Congress ha a bill in now to relieve the 90% guidelines for organizational Tax Exempt status. It appears that the 467th and the 492nd want to continue as is for the foreseeable future. Walt Mundy discussed the \$125,000 upgrade of the 2ADA wall at the Mighty Eighth Museum and that the Groups were going for the \$25,000 and wanted the 2ADA to cover the \$100,000. This will be brought up next year. It was discussed that the belief of the 467th is that the 2ADA should look to the Heritage League for the continuation of the 2ADA functions and maintain control States side of the 2ADA business. The 8th Air Force is still the largest organization in the world, we are a part of it and should sustain its memory of our part. John Upp discussed and passed out his ideas on membership and it was agreed that he would refine his proposal and submit it. In many ways, it appears that there is a group within the 2ADA that want to discontinue the States side aspect of the organization and turn everything over to our English friends. This has some merit, but it was discussed that could not the arrangement continue as it is now with the Heritage League taking over the rains of the 2 ADA and continuing the current relationship with the Trust Governors. If perpetual status is achieved for the Memorial Library and the Fulbright Librarian, then there should not be a great decent to continuing the organization within the United States.
- 8. The congressional bill to relieve the 90% requirement for veteran membership in order to qualify as a 501© (19) organization was discussed. An effort to obtain the bill identification so that members may write their congressman will be put in the next issue of the newsletter. Brian Mahoney stated that it was not very difficult to change from a c(19) to a c(3) which is educational and you have the same tax advantages.
- 9. John Upp discussed his proposal to better identify the membership and its categories and it was totally

agreed that this identification is important and necessary.

They made their home in Guymon before moving to Dumas, Texas in mid 1960 where Harry worked as a salesman. In mid 1970 they moved to Laverne. In early 1990 they moved to Woodward. Harry was a member of the American Legion in Laverne and the VFW Post #1335 in Woodward. He was a wonderful cook and loved hunting and fishing with his grandchildren. He is survived by his wife, Juanita Angle of Woodward; one daughter; three step-children; 10 grandchildren and 16 greatgrandchildren; and a sister.
