FROM THE PREZ - WALTER J. MUNDY

It will be a hard act to follow. The Savannah convention was one of our best. The Mighty Eighth Heritage Museum was impressive. Although there was a very noticeable lack of 2nd Air Division, B-24's and the recognition of the winning role we played in the finest days of the Eighth Air Force, we were able to get our message to General Shuler and his staff. General Shuler is committed to creating a major representation of the 2nd Air Division. A major model of B-24 (we will lobby hard to make it a replica of the "Witch") is planned.

Neal Sorensen advised us that the Bronze B-24 project proposed for the Air Force Academy will also produce a large wood model of the B-24 which could be integrated in the Mighty Eighth Museum. This project is estimated to cost approximately 170 to 180 thousand dollars. This breaks down to about 12 to 13 thousand per bomb group (average) as a 2ADA fund raising project. I intend to discuss this project at the 2ADA Executive Committee Meeting.

Following our departure from Savannah, Ruth and I flew to Charlotte, N.C. where we were to connect with our flight back to California. We arranged for a four-day delay en route and rented a car to drive to Ellenville, N.Y. We were guests of the Nevele Hotel which has been selected as our 1997 Convention Site. The Nevele is ideally located in a beautiful mountain valley approximately 40 miles from West Point Military Academy and The Hyde Park home of President Roosevelt. It is also about 35 miles from Newburgh's Stewart International Airport. The official 1997 Convention Registration forms will be published in the April 1, 1997 Poop From the Group. I urge you to make your plans now to come to the convention scheduled for September 23 through 28, 1997. We have reserved 126 plus or minus 24 rooms in the main building. Cutoff date for rooms will be August 25, 1997.

The hotel convention cost has not yet been determined. We want to give you a total package cost to include room for four nights, four breakfasts, four lunches (at hotel or boxed if on tour), three host bars, three dinners and one banquet. Hotel meals will be in the Group dining area and will be "All You Can Eat" selections from full

Live music and dancing will be available in the evening and a floor show will be held Friday and Saturday evening.

Considering the quality of the rooms and the extent of the facilities including indoor swimming pool, Jacuzzi, steam room, dry sauna, indoor handball, tennis and many more on-site activities, this convention promises to be memorable. On a total cost basis the convention package will be slightly higher than Savannah and comparable to San Diego and Minneapolis.

FROM THE EX-PREZ—Ralph Davis

I asked Walter Mundy to let me cover the convention at Pooler, Georgia. I wanted to express my sincere thanks to Walter and Mary Weaver for the exceptionally fine job they did in setting up this convention. As you who were there know, Walter Weaver had a quad by-pass operation two days before we started with the early birds. Doris and I came in two days early to catch up with what Walt and Mary had prepared over the past twelve months. Mary did come over most every day that she could under the circumstances. Also, Walter and Ruth Mundy came in early to help and Vincent and Gloria LaRussa, Kevin and Myles Coolidge and Pat Robinson were invaluable help and assistance. The response was greater than any of us had anticipated and we saturated the Ramada Inn and had to put people into the Econo Lodge across the street.

For those of you that missed this convention, we believe that you missed one of the best. It was set up to be an experience of friendliness and general exposure to Savannah life style. The meals

started with a buffet style Low Country Broil and then Barbecue; the next two were regular type dinners. Transportation was set up for the Savannah Historic Trip and to The Mighty Eighth Air Force Museum on Friday. Saturday we had transportation to both the Museum and to downtown Savannah for Octoberfest. Sunday there were optional tours along the beach, a low country tour, dolphin watch and in some cases a combination of two.

The biggest advantage of this convention was the location and low cost. The hospitality room that was given us was almost as large as the banquet room. We had many tables set up with memorabilia with room to review the data and then if there was something you wanted to have a copy of, a copy machine was provided to make as many copies as you desired. There was an area just for conversation, snacks and drinks and also a place to have video showing. The motel let us set up our own coffee, tea, soft drinks and snacks in the hospitality room which greatly reduced cost. From everyone I heard this was perhaps the most friendly "get-together" convention they had attended. The personnel of the motel bent over backwards to make things right and to help us have a most successful convention. We have given some lessons learned to Walter Mundy for next year and Walter and Mary Weaver provided Walter Mundy with a total package of things to do and how to get the word out to others. We had 31 first-timers because of their advertising in the military magazines and news releases. The total in attendance was around 254. We had some drop in and about 14 left the day of the banquet.

AT THE BANQUET: As a procedure, the pledge of allegiance and invocation is given only on the night of the banquet. Walter Mundy led the pledge of allegiance and I gave the invocation in the absence of Phillip Day. The banquet head table included Gen. and Annette Shuler (8th AF Museum), Neal and Patricia Sorensen (2ADA), Colonel and Charlotte Shower, Walter and Ruth Mundy, William McGovern (Secretary), Doris Davis and myself. My apologies to the two reserved tables I set up in the front. I intended to introduce the members of the board, past presidents and former squadron commanders, but I forgot to "Write it Down" (Convention joke) and missed them. They were Fred and Jane Holdrege (790th Commander); Jack and Lucile Stevens, Ralph and Yvonne Elliott, Robert and Rosemary Sheehan and Mel Culross (Past Presidents); and Vincent and Gloria LaRussa, Vincent and Carolyn Re, Lloyd Davies (Members of the Board). In attendance were four widows: Vicky Brasier (Carl), Betty Elsen (Tom), Carolyn Lees (Eric) and Jackie Swearingen (Dave). We do deeply appreciate their attendance and hope to see all of them at future conventions. We had seven families in attendance: Coolidge (Myles, Kevin and Kelli), Hannafey (Paul, Grace and William), Samuel (Robert, Robert Jr., and Robin Fillebrown), Schy (Robert, Pat, Harold and Ray), Wilkinson (From England-Andy, Jacky and Tom), Johnson (Dean, Daniel, Mary and Steve Unthank), and Bozy Johnson's Grandchildren (Tara, Monica and Casey). If I missed any, I'm sorry. Distant attendees were Lloyd and Harriet Gilbertson, from Hawaii; Perry and Jill Watts from Salhouse, England; and Andy, Jacky and Tom Wilkinson from Middlesex, England. We had 28 from California, 22 from Florida and 17 from Illinois. There were 90 "early birds" and Jane Holdrege won the drawing of the cost of the convention (\$185). There were 30 - 788th, 32 - 789th, 70 - 790th, and 77 - 791st in attendance. Only one from the 470th Sub Depot. There were two crews that had six (6) members in attendance, a couple of fours and several threes. Unfortunately, I did not get the name of the crews, sorry. If you will drop me a card, I'll see that this oversight is covered.

Three awards were presented: Colonel Shower for exceptional leadership and devotion to all personnel with the Group since its conception; Ralph Elliott for outstanding service and dedication to the Group and devoted service as the 2ADA Group VP; and Phillip G. Day for outstanding service and dedication to the Group and devoted service as the Editor-Publisher of the "POOP FROM GROUP."

General "Buck" Shuler, who we made an "Honorary Member" of the Association, was our guest speaker. He very diplomatically covered the concerns of many as to what appeared to be a lack of B-24 within the museum. He explained how they are making strong efforts to obtain even more than they now have. His people looked over the many items of memorabilia that we have, expressing a keen interest in most all of the data and equipment. Some of the equipment was donated to the museum after the convention. However, most of our memorabilia is being maintained with the 467th, the

reason being is that if we continue to have turnouts as we had at this one, the memorabilia was one of the main interest items of the attendees. General Shuler requested a copy of Jim Mahoney's film and Jim sent him a copy on October 28.

Colonel Shower then addressed the Group making mention of the many people that supported and led to the successful group status. The two new board members were introduced, Vincent LaRussa and Walter Weaver for a 3-year term. Remaining members are Walter Mundy and Lloyd Davies - 2 years and Vincent Re and Ralph Davis - 1 year. After thanking the Group and the board members for their support to me over the past year, the banquet closing was turned over to the new president, Walter Mundy.

I may be stealing Walter and Mary Weaver's input but to date the convention has returned the initial \$500 advanced by the Association and has written a check to the Association for \$3,800. There is still money available to ship memorabilia and finish up final costs which means they may have more to turn in. The insignia pins that I sold during the convention made us \$124.10 over their cost and I still have about 43 pins left for sale. This money is being put on the name tags. The convention covered the balance of cost of the new name tags that we presented officers, board members, group and squadron commanders and attending widows with their husband's name below. It also covered the award plaques as well as the Presidency plaques being made.

I heard from many and the general consensus was that of Fred Holdrege's to Walter Weaver, "that the 1996 convention at Pooler, Georgia was one of the friendliest and warmest convention that they had attended. It takes great people to have one and it takes great people to make one." Enough said!!

One last word. I do sincerely thank Walter Mundy, Vincent LaRussa, Lloyd Davies, Charles Caldwell and Vincent Re as members of the board for their putting up with me and all the action correspondence that I generated throughout the year. I and all of us are always in debt to the excellent support that we get from our treasurer Phillip Day. His work on our group account as well as the "POOP FROM GROUP' has been a mainstay of the organization. He has advised me that he is ready to turn over the "POOP FROM GROUP" to my son Robert who will be doing the publication starting with Vol. 16. I'm sure that Phillip will lend support to him to get him started on the right track. Most of all I want to thank the Group for letting me serve over the last year and for their very intelligent support by electing quality people into the board of

PRESIDENTIAL UNIT CITATION—Marvin R. Davis

Lieutenant General Phillip J. Ford, Eighth Air Force Commander, wrote the following letter, with attachments to Mr. Phillip Upschulte, Principal Deputy Assistant Secretary of the Air Force. All of the attachments were the ones I sent forward with the exception of the 467th Bombing Statistics and that was put together by Mr. Phillip Myers of the 8th Air Force History Office. He also tracked down the award of the Flying Tigers to establish it as a precedent. The help of the 8th Air Force, Second Air Division and many within the 467th have been above call. Let us hope that Mr. Upschulte will have a change of heart and go along with General Ford's excellent recommendation. The letter and Eighth Air Force attachment follows:

Dear Mr. Upschulte,

Since early 1991, the 467th Bomb Group has been trying to gain Presidential recognition for its World War II achievements. After thoroughly reviewing the 467th's performance, I wholeheartedly support this effort. A look back in history emphasizes one fact—the 467th was an elite unit in the "Mighty Eighth." Statistics indicate consistent outstanding performance (See attachment 1).

Based on its consistent record of outstanding achievement, the 467th Bomb Group is long overdue Presidential recognition. Nearly all Distinguished Unit Citations for World War II units were awarded for efforts in single missions. The 386th and 379th Bomb Groups, however, are exceptions. Both units received a DUC for a period of outstanding performance in World War II. Despite the limitations of Public Law 81-501, former Secretary of the Air Force Donald B. Rice awarded the Flying Tigers a Presidential Unit Citation on 21 August 1992 for extraordinary heroism in action

against an armed enemy in World War II. This action established a

The attached letter from Col. Irvine A. Rendle, the 96th Combat Bomb Wing Commander, reflects his intent to submit the 467th and its three subordinate squadrons for a presidential citation based on "overall performance throughout operations against the enemy." In the Eighth's rapid withdrawal from Europe after May 1945, it is quite possible that Colonel Rendle's nomination package became lost in the shuffle. Let's do the right thing and give this outstanding organization its long overdue recognition,

467th Bombing Statistics (Attachment)

The 467th had the best bombing results in Eighth Air Force, from November 1944 to March 1945 and the second best, June to October 1944. From August 1944 to March 1945, the 467th delivered more bombs within 1000 feet of the target than any other Eighth Air Force unit. The unit averaged a 47 percent effectiveness rate compared to 36.2 percent for other groups. Similarly, the rate for bombs within 2000 feet surpassed the Eighth Air Force average, 71 percent compared to 63.7 percent. In January-February 1945, the unit accomplished a tremendous feat, delivering 100 percent of its weapons within 2000 feet of the target. In the 14 April 1945 attack on heavy coastal gun installations near Royan, France, the 467th achieved a perfect strike with all squadrons dropping their weapons within 1000 feet. This achievement broke a previous record of 97 percent from a 13 August 1944 mission to St. Malo, France.

The 467th had an incredible sortie effectiveness rate—94 percent of sortie aircraft completed effective sorties between September 1944 and March 1945. The unit pushed that mark to 97 percent effectiveness in November 1944 and March 1945. The 96th Combat Bomb Wing, its parent organization, averaged 89 percent effectiveness by comparison for the same period.

The 467th had the lowest number of ineffective sorties due to mechanical failure in the 96th Combat Bomb Wing-1.6 percent compared to a 3.1 percent average between September 1944 and March 1945.

The 467th had the lowest number of aircrew losses per credit sortie in the 96th Combat Bomb Wing-4 percent compared to a .48 percent average for the 96th Combat Bomb Wing between September 1944 and March 1945.

The 467th had an extremely low number of aircraft losses per credit sortie-...65 percent compared to .96 percent for the 96th Combat Bomb Wing between September 1944 and March 1945.

The 467th had the greatest percentage of fully operational aircraft-90.3 percent compared to 83.7 percent for the 96th Combat Bomb Wing between September 1944 and March 1945.

MINUTES OF ANNUAL BUSINESS MEETING OF THE MEMBERSHIP OF 467TH BOMBARDMENT GROUP (HEAVY) ASSOCIATION, LTD.

The annual meeting of the members of the 467th Bombardment Group (Heavy) Association, Ltd. was held at the Ramada Inn, Pooler, Georgia, on October 5, 1996.

The meeting was called to order by President Ralph Davis; Officers and Directors present were:

Mr. Charles Caldwell, Director, and Mr. Phillip Day, Treasurer, were absent.

The President appointed all registered members present to be convention delegates.

The President announced that a majority was present. A motion was made and seconded to suspend the reading of the minutes of the last annual meeting from San Diego.

The treasurer's report for fiscal year October 1, 1995 to September 30, 1996 will be published in the POOP, Vol. 15, No. 3. It was announced that total assets had dropped from \$12,675.33 to \$9,562.61 from the past year, but was explainable as the 467th donated \$5,000.00 to the 8th Air Force

Vincent LaRussa spoke on the third printing of the history of the 467th. A profit of \$2,028.00 had been made.

President Davis brought the members up-to-date on the long ongoing procedure to secure a Presidential Unit Citation for the 467th. He has

prepared a package of papers for the signature of the President of 2ADA to be sent to the Eighth Air Force recommending the approval of the award.

Neal Sorensen, the President of 2ADA, spoke. He said that he had endorsed the granting of the citation, that he was impressed by its bombing record and was confident that the citation would be issued. He then referred to the lack of attendance of members of the 467th at the 2ADA conventions and blamed derisive persons at group and division levels. He urged that the 467th hold its convention on the day following the 2ADA convention. It was obvious that his intent was to suggest that the 467th members first attend the 2ADA convention. A coolness to his proposal was apparent among the members. President Sorensen then spoke of the 305th Bomb Group raising the sum of \$160,000.00 for a bronze replica of a B-17 to be placed at the Air Force Academy. He estimated that it would cost about \$170,000.00 for a like replica of a B-24. He invited us to think about such a project which would allow the wood prototype to be placed at the 8th Air Force Museum at Pooler, Georgia. He suggested that all B-24 Units, not just those that were part of the 8th Air Force, be called upon to back the project financially.

Ralph Elliott, Chairman of the Nominating Committee, placed in nomination Walter W. Weaver and Vincent LaRussa to serve as Directors of the association for a term of three years each. There being no further nominations, Walter W. Weaver and Vincent LaRussa were duly elected to serve as Directors of the association for terms of three years. They will join Lloyd Davies and Walt Mundy (2 years) and Vincent Re and Ralph Davis (one year) as Directors of the association.

Walt Mundy, Chairman of the 1997 Convention Committee was called upon to report on the place selected for next year's convention. He stated that a place had been selected but that because of the remarks of Neal Sorensen calling on us to hold our convention on the day following the 2ADA convention, he would like to delay the announcement. When Ralph Davis stated that time was important, he said the announcement would be made on the next day.

Vincent LaRussa spoke on the control tower project and said that much depended on financing by the people in England and that later developments would appear in "POOP.

Ralph Davis, in closing out a very successful year as President of the association, referred to ten actions which were passed by the Board of Directors during the year. All of these actions were printed in "POOP" (April and August issues). He specifically mentioned the item appearing in the August issue of "POOP" calling for the establishment of a group within the Executive Committee to establish a procedure to dissolve the 467th Bomb Group (Heavy) Association, Ltd. and fold it into the Second Air Division Association. He further suggested that a criteria should be established as to the "how and when," along with a recommendation as to the distribution of its assets and that the results of this action be recommended to the Board of Directors and the general membership at the 1997 conven-

Peggy Lou Gair showed a blouse that was made from parachutes that were recovered from a bailout.

Bill McGovern, who served as legal officer of the Group while at Rackheath, then asked for the floor and was granted permission to speak. He said that it was at the 2ADA Reunion in England in 1983 that Phillip Day discussed with him the possibility of incorporation of the members of the 467th Bomb Group. He told Phillip Day that he thought that it was a good idea, that corporate status would give a continuity of purpose and organization, that certain tax benefits would result, that activities involving veterans of the 467th Bomb Group and its attached units could be fostered and encouraged and that the group could be perpetuated through memorials, both domestic and in England. After further correspondence between them, ten years ago in October, 1986, the 467th received its charter from the State of Wisconsin as a non-stock, non-profit corporation. The corporation applied for and was granted exemption from federal income tax under Section 501(a) of the Internal Revenue Code and donors may deduct contributions made for the benefit of the corporation. In furtherance of the corporate purposes, Officers and Directors have been duly elected for the past ten years and by-laws duly adopted. A group of dedicated Officers and Directors have worked to establish a fitting memorial at Rackheath to forever memorialize members of the 467th who fought and died there. Finally, the Lomax Family gave a parcel of land, approximately 6-1/2 feet wide by 4 feet deep, to the 467th corporation, and a Historical Monument was dedicated on July 29, 1990. McGovern concluded his remarks by pointing out that the mechanics of dissolving the corporation are simple, but that before doing so, a decision must be made as to the transfer of ownership to our piece of land upon which the monument is placed. Our corporation by-laws, which Internal Revenue relied on for granting our tax exemption, provide that if the corporation is ever dissolved, its assets must be transferred to an organization which is exempt under Section 501 of the Code or to a federal, state or local government for public purposes. This could be the Second Air Division Association or a church or municipality in the Rackheath area which would agree to forever maintain our monument.

Colonel Shower was then called upon for a few remarks. He chose to defer them to the banquet on the following evening. He received a grand

BITS AND PIECES by Phillip G. Day

There was not a great deal of correspondence to the Editor in the last four months, not even much about Convention 96 and I am disappointed in that. By letter and telephone I received information that it was the friendliest Association gathering that they had attended. When I looked at the attendees (listed in this POOP) I was all the more upset that I was unable to attend.

The short of it is that I had a right thigh femoral artery aneurysm which ruptured on September 6. Fortunately I was in the hospital for the swelling caused by it and my vascular surgeon was in attendance. They put a Greenfield clot catcher in my aorta first thing on the 6th, then operated to bypass the rupture. They saved my life and my leg but nerves were damaged below the knee and I have little or no feeling from the knee down and have foot drop which requires that I wear a brace on my right leg. Physical therapy in hospital and at home for six weeks to learn how to use a walker and cane. There was no way the doctors were going to let me go to Georgia. I get around poorly but am driving the car left footed cautiously. I AM BOUND AND DETERMINED TO GO TO CONVENTION 97 NEXT FALL. WON'T YOU PLAN ON BEING THERE TOO.

from combat fatigue. Now comes James L. Sherrard with Medical Form For Returnees which states "Completed Operational Tour 1 March 45. No Operational Fatigue." I don't find any such in my files.

Speaking medically, every Group had its share of personnel with a venereal disease and the 467th was no exception. In July, 1944 after over a dozen cases were reported to the CO, a policy was adopted, a campaign in the daily "POOP FROM GROUP," and announcement of the establishment of a "Poison Ivy Club" and all personnel known to be infected with VD were listed and given membership. In subsequent editions of "POOP FROM GROUP," new members were announced with name, rank, organization and frequently the city or locale where the VD was contracted. The method worked because the Group was later cited for its low incidence of venereal diseases.

Wesley Bartelt's wife, June, passed away in June after a long battle with cancer, this after losing her leg in 1991. A lovely lady who all of us enjoyed knowing at the several conventions she attended with Wes. Wes is at 5606 Hickory Dr., Ft. Pierce, FL 34982.

She was to have come to Savannah for the presentation of my painting of "Lil Peach" to the museum, named for her by Rufas at Wendover, UT. Lillian never remarried. Her sister wrote me that Lillian died of a massive stroke in June, 1996.


